

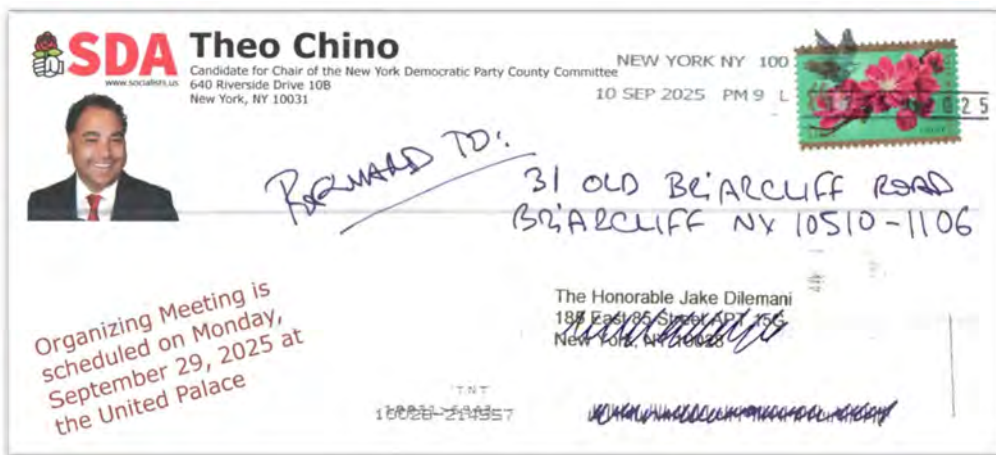

Dear Rosa,

My name is Theo Chino, and if you are receiving this letter, it is because you are one of the 1,654 democrats elected to the County Committee.

You are invited on **September 29th at 7:00 pm** to the **United Palace (4140 Broadway at 175th Street)** for the biannual statutory meeting, where you will elect the Chair and the entire executive board of the Manhattan Democratic Party.

**I am running for Chair, and I am a Socialist.**

If you have never heard much about the County Committee before, it may be because someone in your local Democratic club recognized you as a pillar of your community and entrusted you with this honor.

**What is a Socialist?**

We Socialists believe in a society where government ensures free education and universal healthcare, opposes the death penalty, supports abortion rights, guarantees a universal basic income, upholds the right to unionize, protects the separation of church and state, and affirms that its fundamental role is to make life bearable for all while safeguarding individual liberties.

As Socialists, we are part of the broad Left—alongside Greens, Communists, Anarchists, and the Mélenchonists (Democratic Socialists of America).

The Left stretches as far as Elizabeth Warren.

Further to our right lies Liberalism, which belongs to the Right. Over the years, as the Republican Party was pushed further toward the extreme right, liberals left the GOP and were welcomed into the Democratic Party.

**Why this matters?** Politics is not complicated. **Your vote will shape the direction of the Democratic Party for generations.**

We face a choice: either watch the Republican Party slide deeper into fascism, or work with the Liberal wing of the Democratic Party to restore Republicans to their historic role as the Right in American politics.

As a practical example, I am also running for Congress in NY-13, a safe Democratic district. I am recruiting candidates of all kinds to run for this seat, using **Rep My Block**—a free tool that gives all candidates the same resources I use myself.


This is how I align principle with practice, and it is how I will lead the Manhattan Democratic Party if elected Chair: by organizing and governing in a transparent, practical way. **I hope to earn your vote.**

To run the meeting, I would like to **ask you to vote** for **Rosa Diaz** as Temporary Chair.

**Donald Trump** has been able to rise with **his fascist policies** by exploiting the negativity attached to the words ***Socialism***, ***Communism***, and ***Anarchism***.

Since 2015, I have been publicly writing and speaking about the need to change how we in the United States understand those words. Following Bernie's footsteps, I chose to openly state my politics for what they are: Socialist.

**I have been a card-carrying Socialist since 2004.** When I served on my community board, the chair—who was a Republican—publicly praised Spanish fascist dictator Franco and declared that in the United States, Socialists like me should be shot.

At the time, I did not fully grasp the violence behind those words. Today, however, we clearly see the danger of how normalized that rhetoric has become—and why Donald Trump was able to become our president.

**If we want to fight fascism, we must think outside the box.**

By turning in this Socialist proxy, you are sending a powerful message to the world: here in Manhattan, **we will not tolerate fascism**, and **we are ready to learn about Socialism**. We will think creatively, reclaim our political parties, and chart a new course for our country.

That will require us to participate and recruit across Manhattan—inviting Liberals and moderates to take control of the Republican Party, while we Social Democrats reclaim the Democratic Party. Together, we must ensure that both parties represent the will of Manhattanites, not just the interests of a handful of billionaires.

**This proxy form is the first step in that direction.**

You will see us walking around, so don't hesitate to flag us down. On the reverse side, you will find the universal definition of Socialism.

For the past ten years, I have openly challenged scholars to debate me on this definition—yet none have accepted. **Socialism can only be defined by Socialists**, and the old, erroneous formula of "collectivization of the means of production," peddled by American media, right-wing scholars and Donald Trump, **is not the current definition of** Socialism.

## CHAIRPERSON

- **Theo Chino**

1. *Why are you running, and what do you hope to do if elected to the position?*

I am running again because we must take bold steps to make ours the most inclusive party. Many of the ideas I have already put forward have been implemented, but the boldest reforms remain unfinished.

The Democratic Party of Manhattan must be neutral in organizing primaries and must guarantee #EqualTime for every candidate. Each club should extend that same #EqualTime to every Democrat seeking office.

If elected, I will ensure that every candidate has a platform where club leadership can hear directly from them before making endorsements. I will also guarantee that every candidate for office has a fair opportunity to meet with the County Committee—and that every member of the County Committee has the chance to meet every candidate.

This is how we build trust, fairness, and true democracy inside our party.

2. *What in your experience or background do you believe makes you best-qualified for the position?*  
My forty years of experience navigating among all types of leftist traditions has equipped me to better negotiate the integration of the many factions that make up our Democratic Party.
3. *What actions or involvement have you had with the Manhattan Democratic Party to-date?*  
I have run for Chair of the Manhattan Democratic Party continuously since 2017, and nearly every proposal I put forward—except one—has since been enacted by the County.

For years, I pushed for transforming our website to provide better resources and greater lead time for members. Both of these improvements have now been implemented, but it is still not enough.

If we truly want our party to grow and achieve victory, it is not enough to say that everyone with progressive values is welcome—we must prove it with action.

- **Kyle Ishmael**

1. *Why are you running, and what do you hope to do if elected to the position?*

I'm running to be Chair of the New York County Democratic Committee because I believe our borough must serve as a shining example of a modern Democratic Party that is organized, responsive and principled. We must do the necessary work to understand what binds us together as Democrats, respond to the needs of our communities, and be organized in our ability to reach voters. At a time

when trust in institutions is low, our Party must focus on strengthening the Democratic brand. I look forward to doing that as Chair by building an infrastructure that plays to our strengths as a solid blue sea wall for our city and state. We'll expand our organizing and fundraising efforts so that we can be supportive of efforts to rebuild our democracy, and we'll always lean in to opportunities educate the electorate.

2. *What in your experience or background do you believe makes you best-qualified for the position?*  
Having served as Executive Director for the last seven years, I understand our Party and our potential. As an attorney and experienced manager, I've worked to be a good steward of our rules, our democracy, and our volunteer, public servants who do this unglamorous work of managing our Party -- particularly when more and more people are under threat by a fascist federal government. I've built trusted relationships across our county because I believe in responsive governing that is honest and meets people where they are. I believe we need leadership that aggressively seeks results for our communities; thus I seek to lead a Party that moves boldly to support those candidates. As someone uniquely skilled at building coalitions, I'm excited to do that work throughout our county in the role of Chair.
3. *What actions or involvement have you had with the Manhattan Democratic Party to-date?*  
Twenty years ago -- as a twenty-year old St. John's University kid on summer break -- I learned firsthand I could obtain a list of my neighbors registered as Democrats, write them each a letter asking them to support me for County Committee (whatever that was) and be elected as a Party Official. That planted seed has only grown, and I have proudly served as Executive Director of the Manhattan Democratic Party since my appointment by County Leader Keith L.T. Wright in 2018.

## SECRETARY

### • **Barry Weinberg**

1. *Why are you running, and what do you hope to do if elected to the position?*  
I am running to continue fulfilling my responsibilities of maintaining our party records and ensuring that we are as transparent and accessible as possible while complying with New York State Election Law and our Party Rules and Regulations. At a time when it is critical for our party to be resisting fascism and providing an alternative vision for a more equitable and humane future for America, it is imperative that our party organization can engage and integrate new activists while fighting on every legal and electoral front.
2. *What in your experience or background do you believe makes you best-qualified for the position?*  
I have served as the Secretary of the New York County Democratic Committee since 2019, and I previously served as the County's Executive Director from 2017 to 2019. Over the past 8 years, I have run four County Committee Organizing Meetings, nine Judicial Conventions, and ten District Committee Meetings where we have nominated individuals to run on the Democratic Party line in a special election. These meetings are critical to the functioning of our party, and require extensive and complex notice requirements, meeting preparations, recordkeeping, and filings with the Board of Elections. I also served as the Director of the Manhattan Young Democrats' Open Seat Project, recruiting young people to run for County Committee and reinvigorate our party.

3. *What actions or involvement have you had with the Manhattan Democratic Party to-date?*  
In addition to serving as our County Party Secretary and the MYD Open Seat Project Director, I have been a member of the West Harlem Progressive Democratic Club since 2015, where I have served in various roles, including President and Treasurer. I also serve as a member of the Board of Directors for the Jim Owles Liberal Democratic Club, a citywide left-wing LGBTQ Democratic Club. I have volunteered or worked for numerous Democratic election campaigns, including efforts to unseat members of the so-called Independent Democratic Conference, a group of State Senators elected on the Democratic party line who voted to keep Republicans in power in the State Senate despite the Democrats holding a numeric majority.

## VICE TREASURER

1. *Why are you running, and what do you hope to do if elected to the position?*  
I'm running for Vice Treasurer because I believe transparency, accountability, and efficiency are essential to keeping the Manhattan Democrats strong and growing. My experience managing budgets, coordinating fundraising efforts, and keeping costs under control has prepared me to support the Treasurer in maintaining accurate financial records and ensuring every dollar is used strategically to advance our mission.

If elected, I will partner closely with the Treasurer to make financial reporting clearer and more accessible, so County Committee members and District Leaders can easily see how our funds are allocated. I will explore new tools to simplify revenue tracking, strengthen our financial systems, and work with the Executive Board to ensure we are positioned to meet both immediate needs and future challenges. I am also eager to collaborate with the Fundraising Committee to grow our fundraising capacity and identify new revenue sources that will expand our reach and impact.

2. *What in your experience or background do you believe makes you best-qualified for the position?*  
I bring experience in financial management, record-keeping, and data organization from my personal, professional, and volunteer life. In college and graduate school, I worked several bookkeeping jobs, which taught me the importance of accuracy and accountability. Professionally, I've served as both a Data Coordinator and a Research Analyst, where keeping precise records and presenting detailed information were essential parts of my work. In my personal life, I manage my family's expenses through a detailed Excel spreadsheet that helps us track bills, anticipate costs, and stay on budget. Within the Broadway Democrats, I have maintained the membership database at various points, worked with our Treasurers, and been involved with our fundraisers — always with an eye on keeping costs down while growing revenue.

Perhaps my greatest strength as a support for the Treasure is my love of organizing information in ways that are clear, visual, and accessible to different stakeholders I believe information is only valuable if it can be easily understood and used. (I especially enjoy designing color-coded charts and tables that help make sense of revenue streams and expenditures!) I also believe strongly in planning for a secure financial future. By keeping excellent records, streamlining processes, and helping to grow our fundraising, I want to make sure we can keep improving County Committee meetings and Judicial Conventions, invest in key issue and political campaigns, and meet the growing needs of Manhattan Democrats.

3. *What actions or involvement have you had with the Manhattan Democratic Party to-date?*  
I have been a District Leader for a number of years, representing the northern portion of the 69th A.D. under both our current County Leader and the previous one. I have served on the Rules Committee for a while, and I'm currently Vice-Chair of the County Committee Task Force. Most recently, I completed a term as Sergeant-at-Arms, and I have also had the honor of serving as a Delegate to a Democratic National Convention. I currently serve as 3rd Vice Chair and Chief of Staff to a State Senator, where I manage legislation, budgets, and coalitions that deliver real results. I've led efforts to pass statewide reforms, helped candidates and organizers build effective campaigns, and guided diverse teams through complex challenges. My career blends high-level strategy with deep community work- whether advancing policy at the Capitol or mobilizing neighbors on the ground. That mix of political expertise, organizational skill, and equity-driven leadership makes me well-suited for this role.
